I understand that the party price is \$475 for 12 children (\$525 for non-members), plus \$20 for each additional child, plus tax on full party balance. I further agree that I understand that SPORTIME is responsible for supplying the tennis and multi-sport facilities, staff members, tennis and sports equipment, pizza and soda or juice for all children, and all paper goods. By signing below, I understand that I must remit a non-refundable deposit in the amount of \$250 along with this application to reserve the SPORTIME facilities, date and time for my party. I understand that I am required to provide SPORTIME a guaranteed minimum number of party guests no less than 48 hours prior to the start of my party, and that I am financially responsible for that guaranteed minimum number of party guests, even if the actual number of party guests that attends is fewer than the guaranteed minimum. If more than the guaranteed minimum number of party guests attend, additional charges may apply at the rates set forth above. I understand and agree that the balance remaining for the party, in excess of the deposit, must be paid in full before the party commences. I understand that I am responsible for supplying the birthday cake and candles for my party. I agree that I am the parent or legal guardian of the named participant, and that we will abide by all rules and regulations which now exist or which may be hereafter adopted or amended by SPORTIME. I further acknowledge and agree that there are certain inherent dangers in participating in SPORTIME programs, services and activities, and that SPORTIME shall not be liable for any personal injuries, property damage, or other loss sustained by the named participant in, on or about the premises of SPORTIME, or arising out of the use or intended use of any facilities, equipment or other property of SPORTIME.
